1. Parish Summary

The parish of Rowde is in Devizes Community Area within the local authority area of Wiltshire.

There is a population of 1,382 according to the 2011 Census, comprised of 571 households.

The settlement is bisected by the A342, which links it with the market town of Devizes, approximately two miles to the south east, and Chippenham around nine miles to the north west.

Rowde Village School serves the village for primary education. Rowdeford School, at the far north western end of the village, provides specialist education to a very wide catchment area.

There are a number of clubs and community activities in Rowde including a community run village shop.

2. Introduction

In winter 2019, Wiltshire Council's Commissioning Officers discussed carrying out a rural housing needs survey with Rowde Parish Council, to establish if there was a proven need for affordable housing in the parish.

Such surveys assist officers in identifying those areas with the greatest housing need so that scarce financial resources can be put to best use.

Experience has shown that these surveys need to be carried out at regular intervals if the results are to remain relevant in identifying trends.

- The Commissioning Officers are employed by Wiltshire Council's Housing team to deliver new affordable housing.
- The Commissioning Officers work closely with rural communities and landowners to meet the affordable housing needs of rural communities.
- The survey is funded by members of the Wiltshire Rural Investment Partnership (WRIP).¹
- The Wiltshire Rural Investment Partnership brings together representatives from the
 economic development, regeneration, spatial planning, service development and enabling
 teams of Wiltshire Council together with Registered Provider [housing association] partners
 and Homes England to enable and promote the sustainable delivery of new build housing
 in the rural communities of Wiltshire.²

3. Aim

The aim of carrying out the survey is to investigate the affordable housing needs of local people (or those who need to live) in Rowde parish.

- 'Housing need' can be defined as the need for an individual or household to obtain housing that is suitable to their circumstances.
- It implies that there are problems or limitations with the household's current housing arrangements and that the household is unable to afford or to access suitable accommodation in the private sector.
- Such problems may be concerned with housing costs, size, location, layout, state of repair, or security of tenure either immediately or in the future.

4. Survey Distribution and Methodology

In order to carry out the housing needs survey, questionnaires were collected by the Parish Council for distribution on the 12th March 2019.

To encourage a good response, households were given a pre-paid envelope in which to return the completed survey. The council applies the data protection policy to responses, ensuring that all survey responses remain anonymous.

Residents were asked to return the completed surveys in the pre-paid envelopes by 15th April 2019. The forms were recorded and analysed by the Service Development Officers at Wiltshire Council.

- A total of 611 questionnaires were distributed to the parish.
- Everyone was asked to complete the first section of the form.
- If a household considered itself in need, or likely to be in need of affordable housing within the next five years, it was invited to complete the rest of the survey.
- There was a good response rate of 29.5% with 180 replies received.
- This report describes the views only of the residents who returned the questionnaires and these views may not be representative of the wider population of Rowde.
- 3 responses were made online.

5. Key Findings

This report is divided into two parts. The first section looks at existing households in the parish in order to provide a description of the current housing in Rowde. This section also describes the levels of new housing, if any, which would be supported by respondents to the survey.

The second section examines the households who have declared a need for new housing in Rowde. The section begins by describing the overall need for both market and affordable housing in the parish. A financial assessment is then made in order to determine the numbers

of households who have a current need for new affordable housing. The results of this assessment are summarised in the recommendations of the report (Section 8).


Part One - Households currently living in the parish

The first question asked on the survey was whether the respondents' home in Rowde was their main home. 99.4% of those who replied said that it was.

The 2011 Census data for Rowde indicates that 66.9% of households in the parish were owner-occupying, 17.9% were renting from social landlords, 11.4% were privately renting. A further 2.3% described living in shared ownership homes and 1.6% of households were living rent free.3

The chart below shows the tenure of respondents to the survey. The majority (76.7%) of respondents were owner-occupiers, while 13.9% of respondents were living in socially rented properties, 6.7% were renting from a private landlord or letting agency, 2.2% were living in shared ownership homes and 0.6% were living in a tenure described as 'other'. These results indicate a bias in the survey responses toward those living in owner-occupied homes and the rest of this section should be read with this in mind.



The chart below indicates the length of time that respondents have lived in their current home. It shows that the majority of people who responded to the survey have lived in the parish for more than ten years, which is appropriate for the high levels of owner occupation among survey respondents:



Many respondents to the survey lived in family size homes, with 6.7% of respondents having five or more bedrooms in their property. 24% lived in four bedroom homes, 41.3% had three bedrooms and a further 25.1% two bedroom homes. Only 2.8% of respondents lived in homes with one bedroom.

The spread of ages recorded in the survey indicates that 37.9% of respondents were aged over 65 with a further 39.3% aged between 45 and 64 years of age.

Although responses were received from households with younger members and children the majority of respondents were over 45 years of age.

The distance travelled to work can also be a good measure of the sustainability of local housing development, as more people working locally can indicate an ongoing need for local housing. The table below shows how far people in the respondents' households travelled to work:



These results suggest there is a level of sustainability for new housing development in Rowde, indicated by the survey respondents' access to local sources of employment. While 40% of the households' working members usually travel more than ten miles to their place of work, 60% travel less than that, suggesting there are local sources of employment.

Respondents were asked whether anyone currently living in their household would need separate accommodation in the parish now or in the near future, to which 7.2% of respondents (twelve households) answered 'yes', this would indicate a lower level of sustained need for housing in the parish.


Respondents were then asked how many new homes they would support being built in the parish. A large majority of respondents (77.2%) were in support of some new housing in Rowde, with the most popular option (25.1% of respondents) being for between four and ten new homes. 22.8% of respondents were opposed to any new housing in Rowde parish:

Respondents to this section were finally asked what types of housing development, if any, they would support. The types of housing considered most needed in Rowde by the survey respondents were affordable starter homes for young people (60.9%) and family accommodation for rent (42.6%). Full results are given in the chart below (more than one answer could be given):

Part two - Households requiring accommodation in the parish


This section of the report looks initially at all the responses to section two of the survey in order to give a broad picture of the need for both market and affordable housing in the parish. A financial assessment and an evaluation of the current affordable housing in Rowde are then

made in order to describe in more detail the need for specifically affordable (i.e. non-market) housing.

Sixteen respondents replied to this section of the survey, indicating their need for housing in Rowde. The most frequent reason given for needing to move was access problems (e.g. steps, stairs) six households. Other reasons included currently renting and want to buy (four households), living with family and want independence (four households) and to move to cheaper accommodation (four households). Please note more than one answer could be given.


The respondents requiring accommodation in the parish were asked what type of tenure they sought. The expressed need was for all types of tenure, with socially rented homes the most desired. Households could indicate more than one response:


Respondents to this section were also asked what type of housing they required. The most sought-after type was semi-detached properties. Full responses are given in the chart below (more than one answer could be given):

In terms of size, the most popular option was for two bedroom homes and respondents also expressed a need for properties with one, three and four bedrooms. No need was declared for homes with five or more bedrooms:

The respondents were then asked if there was a lack of suitable existing housing in Rowde to meet their needs, to which twelve of the sixteen households (75%) answered 'yes'.

In order to assess the need for affordable housing in Rowde, it is necessary to consider the equity, income and savings levels of respondents. Please note that due to the need to preserve the confidentiality of respondents, only a short summary of the financial assessment is presented below.

Two households responding to this section of the survey estimated having equity in an existing property. The reported levels of savings among the respondents varied from zero/none declared (eight households) to between £2499 and £19,999 (six households) and over £50,000 (two households). Income levels were spread across a broad range. Some were relatively healthy with five respondents reporting household incomes in excess of £40,000pa. Conversely, three households reported an annual household income of less than £10,000pa. The median gross annual income reported by the sixteen households responding to this section of the survey was £29,000 - £30,499pa.

Comparing income, savings and equity levels with affordability in Rowde suggests that nine of the sixteen households would require public assistance in order to achieve their required housing and so would be considered 'in housing need' as defined in Section 3 of this report. These households inform the recommendations of this survey for new affordable housing in Rowde, presented in Section 8.

Of the remaining respondents, two households expressed a desire to purchase accommodation only. On assessing their levels of equity, savings and income an open market purchase was achievable to these households. These households expressed a desire for homes one bedroom and two bedrooms respectively.

Two households did not declare any financial information and the data provided was inconsistent therefore we have been unable to determine the housing need for these households.

Two households expressed a desire to purchase a home or have shared ownership of a home. However based on the income, savings and declared equity these households' aspirations were unachievable and did not meet the financial criteria for low cost home ownership. It should also be noted these households were considered to be adequately housed and so would not qualify to join the social housing register in Wiltshire although it is possible they may qualify for the open market register.

The remaining household expressed a desire to move to bigger socially rented accommodation however on assessing the households' needs they would be considered adequately housed and would not qualify to join the social housing register in Wiltshire.

6. Affordability

In order to investigate affordability, further research has been carried out on house prices in the area.

It is possible to estimate the average property prices in the Rowde area:4

Example calculation for a mortgage

Typically, a household making a single application can obtain a mortgage of 3.5 times their annual income, or 3x annual income for joint applications. Households would generally expect to need a deposit of around 15% of the total price.

If an average two-bedroom property sold in Rowde cost £211,500 then a household may require £31,725 as a deposit. Annual household income would have to be at least £51,364 for a single applicant or £59,925 for joint applicants. The Annual Survey of Hours and Earnings indicates that the gross annual median income of employed persons in Wiltshire in 2018 was $£28.329^5$

- It would be unlikely that a household would be able to purchase a property in this parish without a large deposit, some equity in an existing property or a substantial income.
- First time buyers would generally struggle to meet the criteria necessary for obtaining their own home.
- In some cases intermediate housing (shared ownership or low cost market housing) would be a suitable option, whilst in other instances affordable rented accommodation would be appropriate.

7. Summary

This survey's recommendations (see Section 8 below) concentrate on those households who are unable to afford accommodation on the open market.

This is just a quarter of the research needed for this assessment: the Housing Register of Wiltshire Council, the local Strategic Housing Market Assessment and the advice from allocation staff who manage the Register must also be taken into account.

- In April 2019, there were two households on the Wiltshire Council Housing Register seeking affordable accommodation in Rowde parish. The household requirements were for one and two bedroom accommodation respectively; these households are also described in section 8 of this report as in need of affordable housing. It should be noted that the housing register is not static and therefore any full assessment of housing need in the parish must take account of the register as it changes.⁶
- The 2011 Census recorded one hundred and two social homes in the parish.⁷ These properties represent 17.9% of the total housing in Rowde, which is higher than the Wiltshire affordable housing average of 14.7%⁸
- The social housing in Rowde had a 4.9% re-let rate in the past year: from the first to the fourth quarter of 2018/19, only five social homes were re-let in the parish.⁹
- The low levels and turnover of social housing in the parish suggest that very few of the households responding to section two of this survey and in need of affordable accommodation could meet their needs through accessing the existing social housing of the parish.

8. Recommendations

This survey's recommendations concentrate on households unable to afford accommodation on the open market.

The following indicates the minimum need over the next three years for new affordable housing development in the parish, based on the responses to the survey. The recommendations describe a snapshot of the need for affordable housing at the time the survey was conducted and do not take account of future changes in need, for example arising from the changing housing needs of employees of local businesses. The recommendations may not represent the parish's full housing need as responses were not received from every household, for example households which are on the Housing Register but have not completed a questionnaire are not included in these recommendations (see Section 7). In order to fully assess the housing need in the parish, the recommendations need to be considered alongside evidence provided by Wiltshire Council's Housing Register, the Strategic Housing Market Assessment, and the advice of allocation staff who manage the Register.
